THEODOR REIK

The Unknown Murderer

Translated from the German by DR. KATHERINE JONES

There is hardly a question connected with crime that the author does not consider in this interesting book. He analyses the interest we all take in crime, and the qualifications possessed by various officials concerned with it, and he discusses their value and limitations. He deals fully with the vexed question of circumstantial evidence, comparing the ideal of the judicial mind, strict logic, with the requirements of the psychological mind when the latter is faced with the solution of a crime. He enlivens his discussion by highly interesting and well-chosen examples. He passes on to the murderer's psychology, and explains through the method provided by psycho-analysis certain hitherto very puzzling facts, such as the criminal's carelessness: his return to the scene of the crime, his lavish provision of clues, etc. The author does not limit himself to recent crimes and institutions, but gives a full analysis of primitive as well as Greek and Old German methods in the detection and punishment of crime, always keeping in touch with the realities of to-day by comparing them with present-day ways. He goes on to describe his ideas about the judicial procedure of the future and the contribution psycho-analysis will make to it. In his last chapters, he deals with such well-known psycho-analytic concepts as repression and the omnipotence of thought influencing accused and accuser.

Noah and the Waters

This work was begun as the "book" for a choral ballet. The author, however, soon discovered he was producing something in the tradition of the mediæval morality plays. *Noah and the Waters* is probably not, on the other hand, suitable as it stands for the modern stage: like that of the morality plays, its drama derives largely from the weight and imminence of the issue it represents, and little from any conscious dramatic construction. This issue is the choice that must be made by Noah between clinging to his old life and trusting himself to the Flood. The immediate significance of his choice is best indicated in the well-known words: ". . . disintegration of . . . the old order of society becomes so active, so acute, that a small part of the ruling class breaks away to make common cause with the revolutionary class, the class which holds the future in its hands." The theme is carried out in a mixture of poetry, doggerel and rhetoric. The *dramatis personæ* are: Chorus; the Two Voices, who speak for Noah and may be identified with the death-will and the life-will; Noah; Three Burgesses; the Flood.

JULIAN BELL
Work for the Winter

This is Mr. Bell's second book of poems. His first, *Winter Movement*, published in 1930, placed him at once among the select band of young writers whose work is included in the frequent anthologies of "modern verse." His poetry is not quite as "modern" as some, for it rarely, if ever, conforms to the most modern fashion of obscurity; it has the impress of its age without ever breaking completely with the deepest traditions of English poetry. Mr. Bell is at present Professor of English Literature in Wuhan University, China.

The Authorship of
Wuthering Heights

Did Branwell Brontë write, or have a hand in writing, *Wuthering Heights*? The question has often been discussed, and some of the many Brontë plays, recently staged, have given it publicity by depicting Branwell as "the only begotter" of the famous novel. Dramatic licence is, however, a different thing from literary investigation. Miss Cooper Willis in this book tackles the question from the only point of view which provides conclusive test of authorship, namely the literary style of *Wuthering Heights*. By analysis and comparison of the writing in *Wuthering Heights* and that in the fragment of a story which is known to have been written by Branwell, she shows that there can be no real doubt as to the authorship of the novel.

Biography

MARY GORDON
Chase of the Wild Goose

This book is the story of the two famous "Ladies of Llangollen," Lady Eleanor Butler and Sarah Ponsonby. These two women—intelligent, spirited, and beautiful—created in their circle and their day—the Irish aristocracy of the mid-eighteenth century—a sensation and a scandal, by their refusal to accept the conventions which surrounded the women of the period. They do not appear to have been consciously "reformers," but merely to have lived two hundred years too soon. For a hundred years after their deaths, their characters suffered detraction and their history falsification at the hands of their biographers. The present book is an attempt to set their story in what would seem to the twentieth century its true perspective. Partly because the records of their early life are meagre, and partly because she had another end in view, Dr. Gordon uses neither the method of straight biography nor the medium of fiction. Her book is a combination of fact and imaginative reconstruction, which can best be described in her own words: "A woman of the present day, herself able to reach partially out of Time, attempts to waken them and draw them back in Time, and to restore to them the essentials of their lost hundred years. The changed attitude towards women in the twentieth century has fulfilled their dreams, and an extended life of movement in the world is again possible for them if they will consent to take it."

The League of Nations

The complete story told for young people

Between the years 1925 and 1929, the Hogarth Press published a series of four small books by Mrs. Innes which together gave an account of the foundation, the constitution, and the various activities of the League of Nations, written especially for young people. These books—*The Story of the League of Nations*, *How the League of Nations Works*, *The League of Nations and the World's Workers*, *The Reign of Law*—have had a very wide circulation in schools and among various educational bodies. *The Story of the League* has gone through five impressions, and this fifth impression is now nearly exhausted. The opportunity has therefore been taken to bring out the present volume, which covers the field of all four of these books; it has been expanded and brought up to date, and includes chapters on the Manchurian and the Abyssinian crises, a new chapter on the Conventions, an account of recent League activities connected with Health and Refugees, and a survey of the whole work of the League from its beginning to the present day.

Nearly everyone agrees that the Italo-Abyssinian affair was a test case for the League system, probably a final test, in case of failure, of the League and what is called the system of collective security. Mr. Woolf deals in this pamphlet with some of the long-range lessons of the dispute and the way in which it was handled by the Great Powers in the League. He shows that there is a widespread and disastrous misunderstanding of what a system of collective security involves, and great confusion both among statesmen and parties with regard to elementary principles of a peace policy.

The Future of Colonies

The Abyssinian conflict has raised once again the question not only of the ethics but also of the economics of colonial acquisition and ownership. In this essay, Mr. Barnes discusses the possibility of reorganizing the old colonial system by reference not to the selfish interests of a suzerain power but to a world community and a world order. In present-day conditions this, he suggests, must involve bringing most British colonies and protectorates under the ægis of the League of Nations, assimilating their status to that of mandated territories, and accepting in respect of their administration the supervision of the Permanent Mandates Commission. The terms of such mandates would need to be stricter in some ways than those at present in force, and the powers of the League Council and the Mandates Commission would need to be enlarged.

LEO TOLSTOY On Socialism

Translated from the Russian by L. PERNO

This essay is the last thing written by Tolstoy, and has never previously been published. It was in his hands for the last time on October 27th, 1910, and he died on November 7th. It was written in reply to a request from the editor of a Bohemian newspaper, *Mlade Proudý*. The editor, after describing the persecution of young Bohemians of the National Socialist Party, informed Tolstoy that some of them were publishing a book containing articles and essays on social and economic questions. He asked Tolstoy to contribute to the book. In answer to the request, Tolstoy began to write the essay now published, but it is clear from references to it in his Diary that it was not finished or revised at the time of his death. The last entry in the Diary referring to it is on October 30th: "Have lost my article *On Socialism*. What a pity! No, it does not matter."

It is written by eight members of the Friends Anti-War Group and the No More War Movement, and was originally published jointly by these bodies in May 1935, this first edition being exhausted within six months of publication.
